HISTORY AND WELCOME

Thank you for considering Geneva, Illinois as your next business location! Selected as the Kane County seat in 1835, Geneva is located in the Fox River Valley 40 miles west of Chicago. We're known for our historic downtown business district (over 700,000 s.f.), the Geneva Commons Lifestyle Shopping Center on Randall Road, the Geneva Business Park (adjacent to DuPage National Airport), Kane County Cougar baseball, festivals, bike trails, and fun!

Geneva is a city of 21,901 people (2004 census). Within the 5 mile ring from downtown Geneva over 110,948 people live in 37,968 households with a 2008 estimated avg. household income of \$116,640 – 69% of households have an income greater than \$75,000. (source: Claritas)

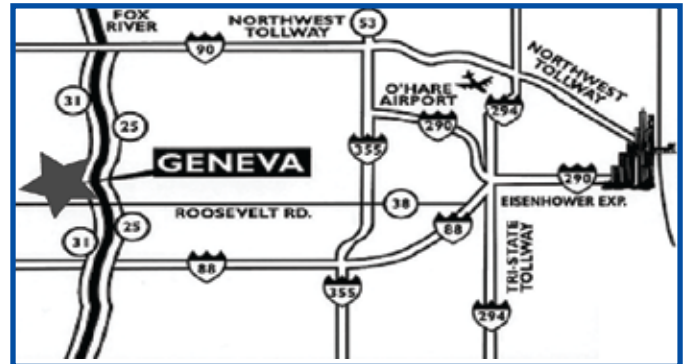
The railroad arrived in 1853, bringing passenger service to Chicago and freight lines. Since 1840, food manufacturing has remained a major industry. Over 1000 businesses call Geneva home and enjoy our lower cost municipal electric utility. Our largest employers are Delnor-Community Hospital, Kane County, Burgess Norton, Johnson Controls, Peacock Engineering, Millard, Production Packaging, Excel North American Logistics, Houghton Mifflin, FONA, The Little Traveler, Gordon Flesch, Industrial Hard Chrome, and Continental Envelope.

Geneva's character is found in its historic architecture, adaptive re-use of historic buildings, graceful trees, and attention to landscaping. Open space and recreation abound with 700 acres of park land (48 parks), a skate park, miniature golf course, swimming pool, the 580 acre Prairie Green Preserve, 497 acres of County forest preserves, two golf courses in Geneva plus another 12 (public & private) courses in the vicinity.

Geneva citizens are actively involved in decision making through a wide range of commissions and civic organizations. Our healthy business climate is augmented and maintained through City partnerships with the Geneva Chamber of Commerce, Geneva Downtown Partnership, Cultural Arts Commission, and a citizen's Strategic Plan Advisory Committee.

With festivals and events every month, downtown Geneva is a place to connect with others, whether for a cup of coffee, fine dining, pizza with the family, shopping, or an afternoon browsing the art galleries. Stop in any business and you will know Geneva is a welcoming place, offering professional opportunities. UTILITIES

Water and Sanitary Service Provided by the City of Geneva

In 2008 the City constructed a \$30 MIL Reverse Osmosis Membrane Filtration Plant which provides excellent water quality, reduced water hardness levels to 6 grains, and is sized for future expansion. For information, contact the Water Division (630) 232-1501.

In 2004 the City completed a \$16.5 MIL Wastewater Treatment Plant improvement. The plant treats 4 to 5 MIL gallons of wastewater per day (1.5 BIL gallons treated in 2007). The City maintains compliance of the NPDES permit at an average of 98% efficiency.
