Executive Summary:			
<p>In 2013 the Street Sweeping Contract was awarded to Hoving Clean Sweep for a 1 year period with the option to extend the contract at a length of one year for two additional years. Staff has just recently received a proposal from Hoving to extend sweeping services for an additional year at no extra cost to the city. The cost for 2017 sweeping services totaled \$73,315.00. The cost for 2018 would be the same. Staff feels that if the city were to go the competitive bidding process for this service the prices would come in higher than the price that has been quoted. During the 2013 bidding process the City received quotes from four different providers that ranged from \$68,320 to \$1,087,860. Prices also included anywhere from a 2% increase per year to a 5% increase per year.</p>
