Executive Summary:			
<p>The FY 20 budget includes funding for the purchase of eight police squad video camera systems. The general parameters of the project included not only the cameras and associated equipment for the police vehicles, but also some basic redacting software as well as the hardware needed to transfer videos from the vehicles to the appropriate storage medium. Four vendors of existing police in-car video systems were evaluated during the process. Of the four quotes, only one vendor, CDS Office Technologies, was able to provide all the deliverables requested including the hardware needed to download the video files. Another significant attribute of the Panasonic system is the ability of the video cameras to interface with the existing laptop computer in the police car. The remaining vendors mount an independent viewing monitor inside the passenger compartment of the vehicle. By feeding the video through the computer it reduces the number of distractions to the officer, as well as limits the potential safety hazards during a collision by having additional equipment mounted in the passenger compartment.</p> <p>The Panasonic, Arbitrator 360, in-car camera system includes software and warranty costs for five years, unlimited cloud-based storage for one year, and downloading hardware for the police facility at a price of \$66,288.00.</p> <p>The Panasonic Arbitrator 360 system will be provided by CDS Office Technologies, who is the current bid holder on the State of Illinois Master Contract. Our existing vehicle outfitter, Ultra Strobe Communications, will install the cameras into the patrol vehicles for a cost not to exceed \$3,500.00.</p>
